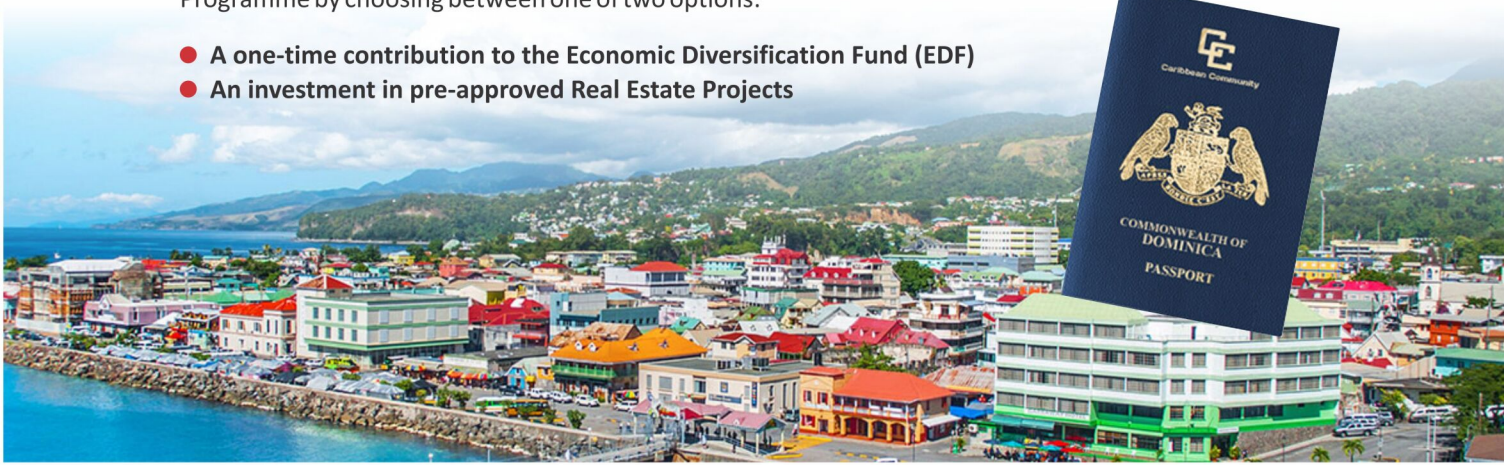

COMMONWEALTH OF DOMINICA INVESTMENTS IN A GLANCE

Applicants and their families may gain citizenship in Dominica through the Citizenship by Investment Programme by choosing between one of two options:

- A one-time contribution to the Economic Diversification Fund (EDF)
- An investment in pre-approved Real Estate Projects



PORTUGAL

Initiated in 2012, The Golden Visa program has several incentives for investors. There are no restrictions on dual citizenship and passport holders can avail all the benefits as other EU residents. It allows visa-free travel to 185+ countries including the Schengen region. You can obtain your second passport within 4 to 8 months. You don't have to stay in country for prolonged periods of time. The holder will only be required to stay 7 days in Portugal in a year during the residency period.

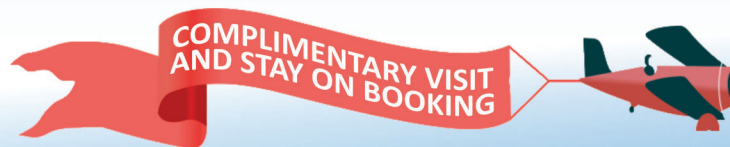
